

# THE FRONT LINE EU LOBBYISTS IN THIRD COUNTRIES

During the last two decades, European organisations operating outside Europe have organized themselves into pan-European business organisations to more effectively represent their interests vis-à-vis the governments in their host countries. These European Business Organisations (EBOs) or European Chambers of Commerce are playing an important role in addressing the European interest in trade, service and investment issues.

European Chambers of Commerce are composed of European national business groups in the country as well as direct corporate members. They articulate, represent, promote and support the interests of their members in the country and region through collective advocacy and networking activities to promote bilateral trade, services and investments between the countries of Europea and the country in which their members operate. They provide European businesses with a channel of communication and lobbying to the European and the country's political and economic authorities and business associations. They represent an interlocutor of choice for the country government and the EU institutions.

The Commission relies heavily on EU business to provide much of the information on the barriers which affect their trade or investment with third counties. As the main homologated organisation representing EU business in third countries, the European Business Organisations around the world, and especially in Asia have proved to be a key facilitator in relaying market access and investment barrier information to the European Commission. The EBOs have also been the main advocacy organisation on the frontlines in the third country often dealing directly with the host country Governments on these issues through the issuing on Position Papers and regular Business-Government dialogues.

After nine years of cooperation, the EBO network is now representing European business in 20 countries in five continents outside Europe, and altogether represent the interests of thousands of European corporations abroad.
